## **Breedon on the Hill Parish Council General Privacy Notice**

When you contact Breedon on the Hill Parish Council.

The information you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and respond to your correspondence, advise, provide information, send invoices and receipts and other matters relating to parish council services and provisions.

Your personal information will not be shared with any third party without your prior consent.

### **Breedon on the Hill Parish Council Right to Process Information**

GDPR Article 6 (1) (a) (b) and (c)

Processing is with consent of the data subject

or

Processing is necessary for compliance with a legal obligation

or

Processing is necessary for the performance of a contract with the data subject or to take steps to enter into a contract

### **Information Security**

Breedon on the Hill Parish Council cares to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and relevant policies.

We will only keep your data for the purpose it was collected for and only for as long as is necessary, after which it will be deleted or shredded.

### **Your Rights**

#### **Access to Information**

You have the right to request access to the information we have on you. You can do this by contacting us by email or post. You will be required to provide proof of identity.

#### **Information Correction**

If you believe that the information we have about you is incorrect, you may contact us so that we can update it and keep your data accurate.

#### **Information Deletion**

If you wish Breedon on the Hill Parish Council to delete the information about you, please contact us.

#### **Right to Object**

If you believe that your data is not being processed for the purpose it has been collected for, you may object, please contact us

### **Rights Related to Automated Decision Making and Profiling**

Breedon on the Hill Parish Council does not use automated decision making or profiling of personal data.

### **To Sum Up**

In accordance with the law, we only collect a limited amount of information about you that is necessary for correspondence, information and service provision. We do not use profiling, we do not sell or pass your data to third parties. We do not use your data for purposes other than those specified. We make sure your data is stored securely. We delete all information deemed to be no longer necessary. We constantly review our Privacy Policies to keep it up to date in protecting your data.
